MANY OF THESE STUDENTS ARE OVER-AGE AND UNDER-CREDIT FOR THEIR GRADE LEVEL, HAVE ATTENDANCE PROBLEMS, AND HAVE BEHAVIORAL OR EMOTIONAL CHALLENGES.
